### About Kardinia

Kardinia Capital ("Kardinia") is a boutique asset manager which has a single product focus, managing the Kardinia Long Short Fund (the "Fund"). Kardinia is wholly-owned by the team, who also invest significantly in the strategy – ensuring our goals are aligned with those of our investors.

### Kardinia Long Short Fund

The Kardinia Long Short Fund invests in listed Australian securities using a long/short strategy. It aims to generate consistent positive returns in all market conditions, with an overarching philosophy of capital protection. It provides variable exposure to the equity market, with a track record of minimising losses in drawdowns.
